About Josephine J. Decima

During her nearly 40 year career in teaching, Josephine J. Decima— or Josie as she was known by her family and friends — was a pioneer in the field of special education in central

Pennsylvania. Josie's dream was to become an elementary school teacher, a profession she pursued after majoring in Home Economics at Seton Hill University and becoming the first in her family to receive a college scholarship and degree. She later returned to college and was awarded a second degree in Special Education.

Josie found her true calling in the early 1960s when she began working with children with mental and physical challenges under a new program funded by Dauphin County Schools. It was here

that she developed her great love for pupils with special needs who were not integrated into the main stream of public education. Josie was one of the leading proponents of inclusive education and was instrumental in having the first high school diploma awarded to a student with special needs. Many of her ideas for teaching came from her background as a home economics teacher, introducing meal planning, sewing, and the love of cooking to her students. Her belief that students with special needs were entitled to a strong academic program supplemented by life skills training provided her with the drive to fight for improved instructional programs and experiences for all children with physical and/or mental challenges.

Josie taught at Melrose and Paxtonia Elementary schools in Dauphin County where administrators provided a classroom for her students. Josie's hard work and commitment to her students enabled her

services.

By the early 1970s, the Commonwealth

School and retired from a long and successful career in education in 1982 as a Master Itinerate Teacher for the CAIU.

Josephine Decima passed away in 2009 and will be remembered as a wonderful homemaker and wife of August R. Decima. She was the mother of four, beloved grandmother and great-grandmother, sister, and cherished friend. Her memory lives on in all who knew and loved her. Josie was a pioneer in the field of special education, a lifelong advocate for children with physical and mental challenges, and an inspirational role model for all teachers. The CAIU proudly established the Josephine J. Decima Award in 2010 to recognize and honor teachers who exemplify Josie's outstanding work on behalf of students with special needs.

The Josephine J. Decima Award is presented annually to a teacher who works within the CAIU service area and whose commitment and service in the field of special education epitomizes the qualities that Josephine Decima demonstrated in her work with children. These include:

- Compassion for students with special needs.
- Commitment to help children with special needs become a vital part of the community.
- Effort to provide valuable and practical life experiences for students with special needs.
- Willingness to share knowledge, skills, and experiences with colleagues in order to strengthen educational programs and pedagogy.
- Initiative to seek and provide services for students with special needs.
